





2. Immediately, you'll see a graph showing 3rd, 4th, and 5th parties.


3. Click "Filters."

4. Next, select the Relationship of Monitored and Unmonitored 3rd Party Vendors.








7. Now, we want to scan through the list, looking for interesting FocusTags™.

We see a non-standard vendor with a Data Breach. This is something we'll want to investigate.

When looking at the vendor website, it's an web animation plugin that could be installed on critical servers, and could present a major problem if not addressed.
